As a follow on from our discussion at last months meeting about wheels, I have more information. This week as I drove past the airport I saw the ACT government Vehicle safety inspector setting up on the opposite side of the road. So I turned around and stopped for a chat.

At first they were a bit taken aback as they probably don't have people doing U turns to **get a roadworth inspection**. But as I was driving my several month old XR6T they took one look and figured not much would be worn out yet, so we got to talking.

A P76 can be fitted with any size wheel provided they do not change the overall diameter by 15mm. And the track by more than 25mm. This means you can put 16 or 17 inch rims provided they are fitted with the correct lower profile tyres. You can also put as wide a tyres as you like, provided the track which is the distance between the centre of both rear tyres is not altered by more than 25mm.

So Geoff can order his 17x7's for the front and 20x9's for the rears.

MOVING AN UNREGISTERED VEHICLE

Payment details and information on moving an unregistered vehicle in the Australian Capital Territory. You must not drive an unregistered vehicle on the road unless you have an unregistered vehicle permit (UVP), which can be purchased from the Motor Vehicle Registry or an <u>ACT Government Shopfront</u>. The permit is issued to enable a vehicle to be repaired prior to registration or to be moved from one site to another. The permit is necessary to cover registration and third party insurance for the vehicle

while it is being used on the road.

Requirements

To obtain a UVP you need to provide the following at a minimum:

- Proof of identity and residency
- Registration number of vehicle if available
- Make and model of vehicle
- Type of vehicle
- Colour 1
- Month and year of manufacture
- Engine number, except for trailers
- GVM for trucks
- Engine capacity for motobikes

- A vehicle inspection report for UVPs exceeding one day's duration where the vehicle could not be registered without an inspection being conducted
- Vehicle identification number if the vehicle was manufactured 1989 onwards
- Chassis number if manufactured up to 1989

Customers may provide an interstate inspection report, provided it meets at least the minimum roadworthy requirements.
